1. Students will be given a variety of tasks UNDER ADULT SUPERVISION once they have proven proficiency in these tasks. These are: **climbing ladders, pulling ropes, hanging lights on a batten, working in the catwalk, moving sets, using power tools and lifting bulky/heavy objects (ONLY AFTER TRAINING BY TRAINED STAFF students 17 and above with parental permission may operate genie lifts)**. This is essential to the curriculum for this class. 5. **Horseplay** is not acceptable and will not be tolerated. Any behavior that jeopardizes the safety or well-being of other students will result in disciplinary action
